How to transition to the new Act

The original intent was to move from the Canada Not-for-Profit Corporations Act (CNCA) to the Ontario Not-for-profit Corporations Act (ONCA). However, the Ontario government recently announced the ONCA will be delayed for at least two years. As a

result, it was agreed that CCSTA would complete the necessary steps to comply with the CNCA and remain with the CNCA for the foreseeable future. We will continue to complete the necessary work in short order.

The main change for CCSTA is the requirement of the provincial members, through a representative, to confirm the appointment of all provincial directors. CCSTA will be writing the provincial association to establish the necessary guidelines.
